This document sets out the Charges and other amounts payable in connection with **nbn**<sup>®</sup> Sky Muster<sup>®</sup> Plus.

Charges in this **nbn**<sup>®</sup> Sky Muster<sup>®</sup> Plus Price List are divided into:

- Recurring Charges, periodic amounts payable in each Billing Period that a product or service is supplied by **nbn** to RSP; and
- Non-recurring Charges, payable only when certain activities or events occur (e.g. installations, disconnections, Top-Up).

Discounts, credits and rebates to Charges in this **nbn**<sup>®</sup> Sky Muster<sup>®</sup> Plus Price List may be offered from time to time, as set out in the Discounts, Credits and Rebates List.
