* Life to date (LTD) to 31 December due to the legacy premises built under the 3.5M footprint and subsequently swapped into 622K. LTD to 31 December 25 therefore captures earlier construction commencements that pre-date the first 6-month period.

*** The Ready to Order metric currently appears higher than Construction Complete because Construction Complete is only recorded once the entire work package (i.e., the full group of ADAs) is finished and a completion certificate is issued to the delivery partner.

In contrast, Ready to Order is reached progressively as each individual ADA completes physical build, testing, network integration and release to market. To provide a more accurate view of construction progress, from Feb 2026 the Construction Complete metric will be updated to reflect the progressive completion of individual ADAs, rather than waiting for the full work package.

1. Reporting period means each 6-month period ending on 30 June and 31 December in a year, or any part thereof. From 31 December 2030, the reporting period means each 12-month period ending on 31 December in a year, or any part thereof.

2. Where actual values are not available, NBN Co can report estimates and/or proxies as reasonable to satisfy the relevant reporting requirement while the informational limitations are addressed.

3. NBN Co must report updated forecasts on the expected progress on delivery of the NBN Network Upgrade Project for the next reporting period in each of its reports until the completion of the NBN Network Upgrade Project.
